Parish/School Site Visit

Overview and purpose: The United States Conference of Catholic Bishops' (USCCB) Secretariat for Child and Youth Protection as well as the National Review Board, the lay advisory panel to the USCCB on the protection of children and young people, encourage dioceses to institute parish/school site visits on a regular basis. The National Review Board explains that the parish level is where it can truly be determined whether diocesan policies and procedures that comply with the *Charter for the Protection of Children and Young People* are actually being implemented.

To this end, the diocesan Safe Environment Coordinator visits several parishes/schools in the diocese each year to conduct a Safe Environment Parish/School Site Visit. The diocesan Safe Environment Coordinator coordinates with the respective parish/school Youth Protection Coordinator (YPC) to arrange for the site visit. The YPC is asked to be present for the entire site visit.
